Notice of Cancellation of Wholesale Requirements Tariff

Dear Ms. Bose:

Tampa Electric Company (“Tampa Electric”) hereby tenders for filing, pursuant to Section 205 of the Federal Power Act (“FPA”)¹ and Section 35.15 of the Federal Energy Regulatory Commission’s (“Commission’s”) regulations under the FPA (“Regulations”),² a notice of cancellation of its Wholesale Requirements Tariff (“WR Tariff”), which is currently on file as Tampa Electric’s FERC Electric Tariff, Second Revised Volume No. 1. Tampa Electric requests that the cancellation of the WR Tariff be made effective on June 20, 2019.

I. THE REASON FOR THE CANCELLATION

Tampa Electric’s WR Tariff was filed initially on January 31, 1991, in Docket No. ER91-241-000, and accepted effective February 28, 1991, by Commission letter order bearing that date. The WR Tariff was amended on subsequent occasions. Most recently, on July 30, 2010, Tampa Electric filed an amendment to the WR Tariff in Docket No. ER10-2061-000 that proposed, among other changes, a formula rate to determine the rates for wholesale requirements service under the tariff. That proceeding culminated in a Commission order issued on July 19, 2012, approving an uncontested settlement pursuant to which the formula rate and associated protocols were established effective March 1, 2011.³

All three of the service agreements under the WR Tariff that existed at the time of Tampa Electric's filing in Docket No. ER10-2061-000 have since been terminated,⁴ and no new service agreements have been entered into. There has been no service under the WR Tariff since the end of 2012. Pursuant to the protocols under the WR Tariff, however, Tampa Electric has been obliged to update the formula rate under the tariff on an annual basis.

Tampa Electric no longer wishes to maintain the WR Tariff. Accordingly, by this notice, Tampa Electric seeks to cancel the WR Tariff.

II. PROPOSED EFFECTIVE DATE

Tampa Electric proposes that the cancellation of the WR Tariff (FERC Electric Tariff, Second Revised Volume No. 1) be made effective on June 20, 2019, the day after this filing. Making the cancellation effective on that date will allow Tampa Electric to avoid the needless preparation and filing of the 2019 annual update of the formula rate under the WR Tariff, which would otherwise be due on or before July 1, 2019. No party would be affected by the cancellation as proposed. Accordingly, Tampa Electric requests a waiver of the 60-day prior notice requirement under Section 35.15 of the Regulations in order to allow a June 20, 2019 effective date for the cancellation.
